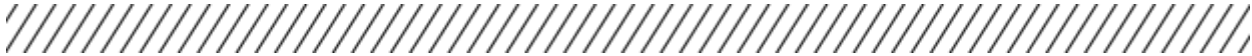

## DECLARATION OF COMPLIANCE

to the European Union Directive on the Restriction of the Use of Certain Hazardous Substances in Electrical and Electronic Equipment 2002/95/EC (RoHS) and Directive 2011/65/EU on the restriction of the use of certain hazardous substances in electrical and electronic equipment (RoHS 2) (\*) OJ L 174, 1.7.2011, p.88, and the COMMISSION DELEGATED DIRECTIVE (EU) 2015/863 of 31 March 2015 amending Annex II to Directive 2011/65/EU of the European Parliament and of the Council as regards the list of restricted substances

Gates components do not qualify as electrical or electronic equipment under Directive 2011/65/EU of the European Parliament and of the Council of 8 June 2011 on the restriction of the use of certain hazardous substances in electrical and electronic equipment (\*). Nevertheless, Gates declares that to the best of its knowledge, and based on its investigation and information available from its suppliers at the time of this declaration, the restricted substance content of Gates manufactured products is below the Maximum Concentration Values (MCVs) set out in Directive 2011/65/EU. Furthermore, Gates declares that it does not intentionally add RoHS restricted chemical substances at concentrations above the specified MCVs into the products they manufacture, though trace amounts below MCVs may exist due to impurities from raw material sources. The RoHS restricted chemical substances and respective MCV refers to the following:

Polybrominated Biphenyls (PBB)	0.1% by weight (1000 parts per million)
Polybrominated Diphenyl Ethers (PBDE)	0.1% by weight (1000 parts per million)
Bis(2-ethylhexyl) phthalate (DEHP)	0.1% by weight (1000 parts per million)
Butyl benzyl phthalate (BBP)	0.1% by weight (1000 parts per million)
Dibutyl phthalate (DBP)	0.1% by weight (1000 parts per million)
Diisobutyl phthalate (DIBP)	0.1% by weight (1000 parts per million)

\* In accordance with RoHS2, Annex III, some products may be subject to exemptions including lead in steel and brass alloys.
